Important Information

The Economic and Social Commission for Western Asia (ESCWA) and the Organisation for Economic Co-operation and Development (OECD) are conducting a joint study on the economic and social impact of open government for the Arab region. The study will reflect on literature review and previous studies and reports made by OECD and ESCWA and other organizations, and it will consider case studies and best practices from Arab and OECD countries. As such, and for the preparation of the study, this Sample Case Submission Form is intended to help the collection efforts for inspiring case studies and best practices from government entities and agencies in the Arab region. It should be noted that selected cases may be published within the ESCWA portal for the open government, which is under design and implementation, as well as the OECD Open Government case platform¹. Furthermore, the relevant experiences will be in featured in the planned Joint OECD-ECSWA meeting of the MENA Working Group on Open and Innovative Government this year, in coordination and collaboration with authorities concerned by these experiences.

The attached form serves as a submission form for open government activities that have been or are currently being developed and implemented at any level of government, and specifically those authorities that are working on open government development in the country, including local levels. The Case Study might cover one of the following topics: Open Government, Open Data, Stakeholder Participation, Collaboration, Citizen Engagement, Transparency, Accountability or Innovation in the Public Sector.

In the context of the attached form, an "activity" refers to any processes and actions taken to work towards the achievement of open government at national, area or local levels. An activity can consist of one or more actions. Participants can submit as many activities they wish, and it is preferable to choose activities with an economic or social impact. ESCWA will make the analysis of the contributions and may contact participants with follow-up questions.

The public sector projects and studies website was developed as part of the government anti-corruption initiative with an objective for OMSAR to establish and regularly maintain a unified database for all public sector studies. The reason behind this initiative is to ensure a global vision for the development process in the public sector and to avoid the repetition of funding and duplication of similar projects and studies across all Lebanese public entities. Ministries and all public bodies, agencies, as well as the general population will benefit from easily accessible information and data.

Ministries and high-level administrators are most of the time making decisions without having access to all relevant data such as existing studies, draft laws, and strategies. Thousands of working hours are lost during the decision-making process in Lebanese public administrations. This is due to the fact that there is no national central access point for government information to utilize when making decisions. Studies website have tried to solve this problem by publishing online a list of all the plans, strategies, and studies prepared for the public sector. The Public Sector Projects and Studies Center is planning to upload all available studies and associated resources to the website in the coming months.

The website was developed to improve coordination among the various government bodies, promote the exchange of information between various government stakeholders, facilitate the search for studies, plans, and projects conducted in various public sector administrations and institutions, put available studies at the disposal of the public administrations and institutions, enhance transparency, and avoid the repetition of identical studies.

The project aims to change the current approach in conducting studies in the public sector to adopt a new policy based on analysis and evaluation of existing data before launching any new project/study. The website should expand to become the unique centralised location for all public sector studies, GIS data, primary and secondary legislations, draft laws, council of minister agenda and decisions, and international agreements and conventions signed by Lebanon.

The website is the first of its kind, providing a single access point to all public sector plans and studies. It organizes those studies by providing a faster search access that will provide the needed information required.

3. Development

3.1. Collaborations & Partnerships

The Public Sector Projects and Studies Center collaborates with all public sector entities and international organizations that conduct studies in Lebanon, and aims in the future to collaborate with academic institutions and the private sector.

The Public Sector Projects and Studies Center collaborates with all public sector entities and international donor organizations, namely:

- Council for Development and Reconstruction (CDR) where many valuable studies, plans, and projects had been carried out and preserved
- 2. **Presidency of the Council of Ministers** which issued some circulars related to the Center
- 3. **Ministry of Finance** which introduced a new mechanism to fight corruption in the development of public sector studies (all the public administrations must provide OMSAR with a copy of each study prepared in order to obtain funding)
- 4. **Central Inspection** in charge of controlling the application of circulars issued by the Presidency of the Council of Ministers and related to the work of the Center.
- 5. **Donors** that finance studies for government entities

Key beneficiaries include decision makers at all level of government, as well as citizens, civil society organizations, students and academic institutions, international organizations, and private sector companies

Through the website, and by making publicly available all existing studies, we are reducing the possibility of replication of the public sector studies, which ultimately reduce the inefficiency in the use of public funds.	
We have observed in the months following the launch of the website a significant decrease in the duplication of	
existing studies (this was observed by the Public Sector Projects and Studies Center which part of its mandate is to approve or disapprove the conducting of studies based on the existence of similar previously conducted studies)

Some Ministries and public administrations are not cooperating nor providing the center with the studies in their
possession. This limits the comprehensiveness of the center's database. While circulars have been issued to ensure
compliance, the legal mechanisms currently in place limit the quick and effective enforcement of the relevent circulars.
